ROUND 2

This grant round opens - Friday, 01 June 2018 at 1200hrs

Closure date for this round - Saturday, 30 June at 2300hrs

(CFA reserves the right to close this round earlier/extend closure date without notice)

Grant applications will be available for individual Brigades – No minimum or maximum amount.

Grant applications up to a maximum of \$250,000 for collective applications from groups of at least 10 Brigades.

Applicants should seek funding to undertake local programs, projects and/or initiatives to:

- strengthen operational capability (including equipment & infrastructure)
- respond to community need
- promote health, safety and wellbeing
- build partnerships and collaboration (including with the community)
- undertake transformational change

Priority will be given to applications that seek to:

- Address immediate needs and enhance operational capabilities
- improve culture, diversity, inclusion and fairness in CFA
- strengthen volunteer leadership skills
- address local risks, such as rural decline, ageing or community growth
- enhance volunteerism, including recruitment, retention and recognition of volunteers, and making volunteering with CFA a more contemporary experience

IMPORTANT - CFA INFRASTRUCTURE PRE-APPROVAL REQUIREMENTS

If your application relates to CFA INFRASTRUCTURE SERVICES (includes, but not limited to such items as building modifications/additions, renovations, generators, security systems, water tanks, LED messaging signs etc.) it is a program requirement that you obtain preapproval from Project Manager - Phillip Hand, (Tel: 03 54302200, Mobile: 0408 303 935) Email- p.hand@cfa.vic.gov.au **prior to commencing your application**.

Applications that are not pre-approved by CFA Infrastructure Services will not be considered under EVGP.

Specifications

- Incomplete applications and/or applications received after the closing date will not be considered.
- All applications must be lodged online please make contact locally should you require support with this process.
- Applicants will be asked to identify what alternative options for funding have been considered including use of local brigade funds. Joint funding proposals using the grant program and brigade funds will be encouraged.
- Applications should articulate how the investment aligns to overall District/Regional priorities and encourage innovation.
- If your application relates to CFA INFRASTRUCTURE SERVICES (includes, but not limited to such items as building modifications/additions, renovations, generators, security systems, water tanks, LED messaging signs etc.) it is a program requirement that you obtain pre-approval from Project Manager Phillip Hand, (Tel: 03 54302200, Mobile: 0408 303 935) Email- p.hand@cfa.vic.gov.au prior to commencing your application.
 - Applications that are not pre-approved by CFA Infrastructure Services will not be considered under EVGP.
- Applications will need to identify if they would require funding for ongoing maintenance and operations and what avenues have been identified to cover such costs.
- Applications that do not comply with the program guidelines many not be considered by the EVGP Assessment Panel.

Region or District based grants are encouraged where the grant can meet the needs of multiple Brigades and are supported by the relevant Captains.

It is the responsibility of Brigade/District/Region to replace assets acquired under this program.

Successful and unsuccessful applicants will be advised.

Successful applicants will be required to follow the acquittal process as advised.

Procurement arrangements may be coordinated by the appropriate CFA program area to ensure compliance with procurement requirements.

Exclusions

If an application was unsuccessful under EVGP – Round 1, please do not resubmit, however you are welcome to apply for an alternative project under Round 2.

Projects commenced prior to final approval are not eligible.

Applications that duplicate existing CFA programs will not be funded.

Equipment that does not meet CFA Safety Standards will not be approved.

Tankers, Big Fills, Specialist Appliances or additions to CFA fleet will not be considered under this program.
